

Complete Game of PA Waiver (Participant and Parent)

Waiver: In signing this waiver form below, I release Complete Game of PA, and all of their agents, employees, independent contractors, equipment suppliers, and members (hereafter collectively referred to as Complete Game) from any claims or responsibility for injuries suffered in any activities or events conducted by Complete Game, whether occurring within or outside of the facility. I knowingly assume all risks associated with participation, even if arising from negligence of the participants or others and assume full responsibility for my (or my child's) participation today and on all future dates.

Verification: I, the participant/parent, certify that I am, or my child is, in good physical condition and can participate in sports and related activities, and I further agree and warrant that at any time I believe conditions to be unsafe, I will immediately discontinue further participation for myself or my child in the activity. If an emergency arises, I authorize the Complete Game staff to request and/or administer medical treatment to myself, or my child, if necessary.

Assumption of inherent risks: I, the adult participant, or minor participant and parent(s) or guardian(s) (hereafter referred to as participant/parent), understand that all activities of Complete Game include inherent risks that cannot be totally eliminated regardless of the care taken by Complete Game. I, the participant/parent know, understand, and appreciate the types of injuries inherent in Complete Game's activities, and hereby knowingly assume all inherent risks of the activities. Furthermore, as a participant/parent, on behalf of myself, my spouse, heirs, personal representatives, and assigns (releasing parties) do hereby waive, release, discharge and covenant not to sue Complete Game for alleged liability from any and all claims arising from the ordinary negligence of the protected parties. I realize accidents, illness, and injuries may still occur. I hereby waive, release and forever discharge Complete Game, the event host venue and/or facility, and all coaches and staff, representatives, employees, contractors, successors and assigns of any and all rights and claims for damages to person and property which may be sustained or occur during participation in any Complete Game program by the participating student whether paid damages, injury or loss are due to negligence or not; and the risks of injury and illness, including, not limited to communicable diseases such as MRSA, Influenza, and Covid-19.

Scope: This agreement applies to personal injury, including death, from incidents or illnesses arising from participation in Complete Game activities including, but not limited to recreational, practice, or competitive activity; events; organized or individual training and conditioning activities; tests; classes and instruction; individual use of facilities, equipment, locker room areas, and all premises, or attendance at such activities whether or not as a participant, including the associated sidewalks and parking lots, and to any and all claims resulting from the damage to, loss of, or theft of property ("the inclusive activities").

Indemnification: I, the participant/parent, also agree to hold harmless, defend, and indemnify Complete Game – that is, defend and pay any costs, including damages awarded, investigation costs, attorney’s fees, and related expenses – from any and all claims arising from me or my child’s participation in the inclusive activities. I, the participant/parent, further agree to hold harmless, defend, and indemnify the Complete Game against any and all claims of co-participants, rescuers, and others arising from the conduct of the participant in the inclusive activities.

Media Waiver: I understand that Complete Game occasionally uses photograph and/or video of Complete Game events such as tournaments, educational events, lessons, and programs for Complete Game promotional purposes. I grant Complete Game permission to use the participating player’s name, image, voice, and identity in any program for promotion of Complete Game including written materials, website materials, video, audio, or other forms. In addition, I authorize Complete Game and its assigns to utilize any and all photographs, pictures or other likeness of me or anyone assigned guardianship to me, as they deem appropriate in its promotional materials or team films.

Clarifying Clauses: I, the participant/parent, confirm that this agreement supersedes any and all previous oral or written promises or agreements. I understand that this is the entire agreement between the Complete Game and myself regarding waiver and acceptance of risk and cannot be modified or changed in any way by representations or statements by any agent or employee of the Complete Game. I, the participant/parent, understand the foregoing assumption of risk, waiver of liability, and indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the State of Pennsylvania, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect, and if legal action is brought, the appropriate trial court for the County of Montgomery, in the State of Pennsylvania has the sole and exclusive jurisdiction and that only the substantive laws of the State of Pennsylvania shall apply. I, spouse and child, willingly agree to comply with the Complete Game’s stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child’s readiness for participation and/or in the facility itself, I will remove my child from participation and bring such attention of the nearest Complete Game official.

Acknowledgement and Understanding: I, the participant/parent, have read and understand this agreement. I understand that I am giving up substantial rights, including the right of the participant/child to sue for damages in the event of death, injury, or loss. I acknowledge that I am voluntarily signing the agreement and intend my signature to be a complete release of all liability, including that due to ordinary negligence by the protected parties, to the greatest extent allowed by the laws of the State of Pennsylvania.
